### INTRODUCTION


• University teachers and PhD students need to write different types of Academic writing pieces.

• These types of academic writing pieces are necessary for their careers both as (prospective) teachers and as researchers who need to disseminate their research outcomes.

## TYPES OF &C&DEMIC WRITING

• The different types of Academic Writing consists of but is not limited to:





1. RESEARCH ARTICLES: a research article is a quite lengthy piece of academic writing presenting the outcomes of research. It is based on the analysis and interpretation of data. It is an original piece of research. Most research articles follow the IMRAD format and are published in scientific / academic journals.

2. REVIEWS: reviews are short articles based on other published books or articles. A review article is not an original piece of research.

- 3. ABSTRACTS: an abstract is a short summary of completed research which describes the work without providing details. An abstracts is a self-contained and concise piece of witting.
- 4. CONFERENCE PAPERS: conference papers are often a combination of written documents and oral presentations. They are usually published in collections called proceedings.
- 5. RESEARCH PROPOSALS: a research proposal is a structured, formal piece of academic writing which explains what, why and how a prospective research is meant to be conducted.

6. THESES and DISSERTATIONS: A dissertation or thesis is a long piece of academic writing reporting original research. It is submitted as part of a postgraduate degree.

7. ESSAYS: essays are often short pieces of writing that present specific ideas or arguments. Their structure consists of an introduction, a boy/development paragraphs and a conclusion. Essays are generally published in scholarly journals.

8. BOOK CHAPTERS: A book chapter in academic writing is a significant part of a book. it helps establish the foundation of a topic and complements the overview of the work's content. It focuses on a particular aspect of the research.
